Announcements

Campbell gave recognition to Cookie Smoak for being inducted into the Atlanta Hospitality Hall of Fame, and for the exposure we have been receiving from our social media. Runyon informed everyone of the upcoming ribbon cutting for the Residence Inn hotel – inviting all the board to support.

Runyon discussed the option of replacing and upgrading the CVB vehicle due to use for both internal travel, exposure, and client site visits. Alexander made a motion to approve up to \$100,000 for up to (2) vehicles and (2) vehicle wraps. Washington seconded the motion, which passed unanimously.

Member/Staff Topics


